

SCHOOL ADMISSIONS POLICIES CONSULTATION GUIDANCE 2024-25

The Diocesan Department for Education has made adaptations to the wording of model admissions policies this year and a full consultation of all policies will be required by 31 January 2023. The Diocese will facilitate this consultation on behalf of the Catholic Education Trusts which are the admission authorities.

The Diocesan Department for Education will send out proposed admissions policies to the Trusts on 16 September. Trusts will send any queries to the Diocese by **27 September 2022**.

The Diocesan Department for Education will send out proposed admissions policies to each school by **30 September 2022**. A full governing body meeting must be arranged to discuss the proposed policy for the school. The Catholic Education Trust is the admissions authority. However, in practice the determination and administration of the school admissions policy is delegated to the local governing committee.

The Diocese's consultation period will take place from 5 December 2022 - 27 January 2023.

Those who must be consulted are:

- the Diocese of Hexham and Newcastle
- all other admission authorities in the relevant area, i.e., the local authority, other local authorities, other Catholic schools in the area;
- other persons in the relevant area who in the opinion of the admission authority have an interest in the proposed admissions, i.e., other schools in the area;
- parents of children between the ages of two and eighteen who are resident in the relevant area.

To meet these consultation requirements, the governing committee **must**:

- check the proposed policy for errors/omissions and submit any queries to the Diocese by 14 November 2022;
- once queries (if any) have been addressed with the Diocese, a copy of the Diocesan approved policy must be published on the school's website by 5 December 2022 and a link sent to the Diocese;
- 3. inform parents of children in the school via letter (see sample letter)/school newsletter/parish newsletter that there are proposed changes to the policy;
- 4. send upon request a copy of the consultation response form (see sample response form) to interested parties via email/post;
- 5. document all aspects of the consultation;
- 6. collate and analyse responses from the consultation.
- 7. Agree on policy at full governing body meeting following consultation and inform the Diocese.

See the checklist enclosed to ensure you meet all requirements.

On your behalf, the Diocese will:

- 1. place on the Diocesan website a link to the school's website where a copy of the proposed policy and proposed changes will be found;
- 2. alert the local authority in which the school is situated, local schools and other local authorities to the proposed policies and changes;
- 3. place an advert in the local newspaper to alert people in the local area to the consultations.

Key Dates

16 September 2022

Trusts will receive proposed admissions policies for review.

27 September 2022

Deadline for Trusts to send queries to Diocese.

30 September 2022

Schools will receive the proposed admissions policies.

14 November 2022

Deadline for schools to send queries to Diocese.

5 December 2022 - 27 January 2023

Diocesan consultation period.

27 January - 28 February 2023

A full governing body meeting must be arranged to discuss the consultation outcome and finalise the admission arrangements for 2024-25. A record of the consultation responses and decision(s) made at this meeting **must** be minuted.

28 February 2023

Deadline for the school (on behalf of the admissions authority) to send a copy of their determined admissions policy for 2024-25 to the Diocesan Department for Education.

15 March 2023

Deadline for the Diocesan Department for Education to send a copy of the determined admissions policy for 2024-25 to the local authority.

Deadline for schools, on behalf of the admissions authority, to publish a copy of their determined admissions policy on their website.

15 May 2023

Timescale if anyone would like to object to the Office of Schools Adjudicator about your school's admission arrangements.
